Thus, after evaluating other external auditors, the Audit & Risk Committee recommended the election of Reyes Tacandong & Co. as the external auditor of the company for FY 2012-2013 at the annual meeting of the stockholders which will be held on 20 February 2013 at the Turf Room, Manila Polo Club, Forbes Park, Makati City at 10:00 o'clock a.m. Representatives of the firm are expected to be present at

the said annual meeting of the stockholders and will be given the opportunity to make a statement and are expected to be available to respond to appropriate questions. Mr. Emmanuel V. Clariño or Ms. Haydee Reyes Arcenas are the partners of Reyes Tacandong & Co. who have been assigned to handle the account of the company for FY 2012-2013.
