This refers to the news article entitled "GBPC, Roxas JV to invest \$100M in 40-megawatt biomass plant" posted in BusinessWorld Online on September 27, 2015, which reported in part that:

"THE JOINT venture (JV) between Global Business Power Corp. (GBPC) and Roxas Holdings, Inc. (RHI) is investing about \$100 million to develop a 40-megawatt (MW) biomass project that will be operational in two years.

Jaime T. Azurin, GBPC executive vice-president, said last week that the two companies will bid out the engineering, procurement and construction (EPC) contract for the project by the end of this year.

. . . .

The official said the project -- which will be located in La Carlota City, Negros Occidental -- costs about \$2.5 million per MW.

But he said this will be recovered once the project gets an allocation under the feed-in tariff scheme, which provides a premium rate for renewable energy projects over a 20-year period.

."

We confirm that GBPC and RHI have commissioned Poyry Energy, Inc. for the Front-End Engineering Design (FEED) of a 40-megawatt cogeneration facility in Negros Occidental, as disclosed in our press release on 12 May 2015. We clarify that while RHI and GBPC intend to establish a joint venture company to operate the facility within two (2) years, no formal joint venture agreement for the biomass project has been executed by GBPC and RHI. RHI will make the necessary disclosures at the appropriate time.
